

PERSONAL DATA PROTECTION

In the Vault Hotel d.o.o. we treat your personal data in accordance with the Personal Data Protection Act that regulates and processes personal data, its procedures and protective measures and responsibility and supervision in the procedures of their processing. With this statement about the personal data protection, the Vault Hotel d.o.o. establishes collection, use and protection policy of the personal data of the interviewed individuals, the visitors of the website www.hotelvaultljubljana.com and everyone that sign in to the e-news system.

Protection of personal data of the users of the website www.hotelvaultljubljana.com

The website users can be physical or legal persons, in which case it stands that personal data is only that of physical persons. The Vault Hotel d.o.o. respects the privacy of users and commits to the careful protection of the data gained from its website, following the Personal Data Protection Act. It also will not transfer such data to third parties or use them for purposes not mentioned in this statement. It can reveal the personal data of the users of its website only if the law requires that, in the case of an investigation or protection against operation that could be harmful for the Vault Hotel d.o.o. itself. Since there are links to other websites on the Vault Hotel d.o.o. website, that are in no relation to it whatsoever, it does not assume any responsibility for the protection of data on them. We will inform you of any possible changes of this statement on the email address, provided by you on the website www.hotelvaultljubljana.com.

Consent to the collection and processing of personal data

User (physical person) of the website that on the latter enters his personal data:

The Vault Hotel commits to the protection of the data of legal persons and the personal data of physical persons that receives through the bank website. With the purpose of preventing unauthorised access to this data or its disclosure, the conservation of accuracy and completeness and the insurance of its appropriate use, the Vault Hotel d.o.o. uses adequate technical and organisational procedures for the protection of personal data, laid down by the Personal Data Protection Act.

- allows the Vault Hotel d.o.o. to establish, collect, maintain, use, process and to store the personal data of the user in the database;
- allows the Vault Hotel d.o.o. implementation of the direct marketing activity;
- states that he is aware that he can request from the Vault Hotel d.o.o. to stop using his personal data for the purposes of direct marketing.

All three points are also logically applicable in the case of legal persons.

Protection of personal data

Personal data entry

On the website, www.hotelvaultljubljana.com, user fills in a form or sends a demand for a certain product or service, where he enters the following personal data:

- surname and name/title; • phone; • e-mail address.

A staff member will contact you, regarding your demand, through your e-mail or phone, depends which one you chose when filling in the form. By providing and confirming your personal data you agree, that the Vault Hotel d.o.o. can process it for the purposes of the direct marketing. At any given time, user can cancel it use for the purposes of the direct marketing. He can do that by sending an e-mail to reservation@hotelvaultljubljana.com. After the cancelation of the permission for the direct marketing we will stop the activity of that and delete from our database all of your personal data, that was collected for the purposes of the direct marketing.

The objectives of collecting, processing, storing and using the data of legal and physical persons are:

- delivering user's demand for a certain tourist product or service;
- the option of user being contacted by the hotel considering certain product or service;
- implementation of the direct marketing activity;
- the analysis of data for statistical and marketing purposes.

We keep the data of legal and physical persons in electronic version. After its management is no longer needed or the registration is cancelled, all the data is deleted or its carriers destroyed.
